Established in 2016, our emergency relief fund has distributed more than \$11.6 million to individuals in the food and beverage industry in crisis. Recipients in crisis experience needs related to medical bills, car accidents, weather catastrophes, family support assistance, and mental health. In 2024, the emergency relief fund provided relief to 1,950 individuals. To qualify for emergency relief funding or mental health services (described below in Line 4b), recipients must have worked in the food and beverage industry for a minimum of 6 months and an average of 30 hours per week. Every applicant must show proof of such employment by providing paycheck stubs and/or W2s.
